MARAE CAPACITY FUND

TE MANA O TE AWA ARE OFFERING A MARAE GRANT FOR UP TO THE AMOUNT OF \$5,000.00. THIS WILL BE AWARDED TO WHANGANUI IWI MARAE WHO WISH TO:

- a) Use as a cash contribution with other funders towards a larger project the marae are leading (i.e. Lotteries or Crown Grants Applications);
- **b)** Complete a concise project to support the infrastructure of your marae (i.e fix something);
- c) A collaborative initiative with other Marae (i.e enter into a strategic discussion about insurance).

TO APPLY FOR THIS FUND YOU NEED TO:

- Provide evidence that the application is supported by the Marae Trustees, e.g. minutes from a marae meeting and a letter signed by the Chairperson, Treasurer and what the marae are seeking to do (option a, b, or c), and how you will go about it;
- Outline the budget based off real costs, and provide quote(s) no older than six (6) months where required;
- Outline what the marae will contribute to the project if applicable;
- Provide a bank slip that verifies the marae trusts bank details;
- Advise the legal status of your marae (e.g. Maori land trusts, Charitable trust board, Incorporated society, marae trust).

IMPORTANT TO NOTE

- Applications will only be considered from Whanganui lwi marae.
- The amount of funding granted is at the discretion of Whanganui Iwi and the Genesis Energy Relationship Group and will depend on the available funds and the number of applications being considered in any one year
- The maximum level of funding allocation available to any one marae under the Marae Facilities Fund, is \$5000. However, marae can choose to collaborate or contribute their allocation towards another marae project
- The fund must be expended within 12 months of the date of grant approval unless otherwise arranged.
- An accountability report must be submitted following completion of the project, or when the fund is fully expended, or 12 months following approval of the fund – whichever comes first.
- The fund can only be used for the purposes it was approved, and may be subject to conditions stipulated by the Whanganui Iwi and Genesis Energy Relationship Group.
- All marae who receive this fund, may be required to send members of the committee to participate in training opportunities facilitated by Te Mana o te Awa (i.e. Governance Training or Workshops to access other funding pools).
- Te Mana o te Awa reserves the right to use fund recipient details for publicity and promotion purposes.
